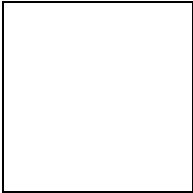
Remarks concerning incoming complaints to the Citizen Rights Center:

1. The number of incoming complaints to the Citizen’s Rights Center during 2000 is 382 complaints.
2. Some complaints are still in the process of review.
3. Some complaints involved more than one party.
4. Issued letters involve more than one party concerning the complaint.
5. A special field survey was prepared to deal with complaints related to the Civil Defense Department, including specific recommendations on its work.
6. The Citizen’s Rights Center has conducted a special research related to newly initiated municipalities by the PNA, following incoming complaints regarding urban and rural infra-structures.
7. Since the eruption of the Intifada in September 2000, the Citizen’s Rights Center has endorsed an emergency plan for action to follow up Israeli violations with a systematic documentation of:
 - ? Martyrs and wounded.
 - ? Dwellings that are shelled or fired at.
 - ? Material damages.
 - ? Chart for main events in the Intifada.
 - ? Affidavits from citizens facing violations.
8. a) Letters issued by the Citizen’s Rights Center directly to relevant authorities totals 82 letters.
 b) Photocopies of letters issued are 35 letters.
 c) There were 18 reminder letters.

9. a) Number of cases taken up and closed: 248 cases.
b) Number of cases still pending: 114 cases.

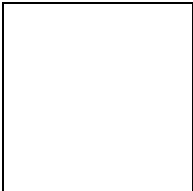

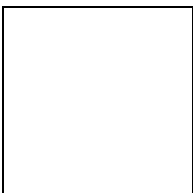
(c) Distribution of Incoming Complaints to the Center of Citizen's Rights According to Governorates (Jan 2000 - Dec 2000)

Main Observations Raised during the Special Session held to discuss Al Multaqa's 2nd Report on Democratic Formation in Palestine (June 21, 2000)

Attendance and the quality of discourse were not at the level of the meeting held a year ago. With all due respect to those attending, diversity of political shades and depth of analysis was not that impressive. Exceptions were the contributions of Taisir Zabri, Abdel Latif Ghaith, Zahira Kamal and Rafiq Natsheh.

The remarks centered on the following two categories:

1) Remarks on the methodology:

- 1) Questions were raised again regarding the title of the report with some participants claiming that there is no democratic formation in Palestine and suggesting that the title could be: "**Concerning the Democratic Issue in Palestine**".
- 2) The language of the report was considered by some as flattering and even as a cover-up of truth from the public.
- 3) The section dealing with the work of ministries and public institutions was considered shallow since it depended on information drawn from the ministries with no objective evaluation of the functioning.
- 4) Summarizing performance by strengths and weaknesses was approved.
- 5) Among the most important methodological comments was the adoption of standard indicators to measure democratic formation. As in the previous year, proposals included the need to redraft the Report along main topics using standard measuring tools. Following are the main parameters, listed at random, for assessing the process of democratic formation:
 - i) Level of popular participation in decision-making.
 - ii) Level of participation in planning at the national and local levels.
 - iii) The issue of pluralism and the transfer of power.
 - iv) The principle of the rule of Law.

- v) The issue of equality, even opportunity and women’s participation in decision-making.
- vi) The value system in the democratic process.
- vii) The level of departmental adherence to jurisdiction and the field of activity.

In general, the elements included in page 95 concerning the measure tools of democratic formation serve the purpose.

2) Remarks concerning the content:

- 1) Neglecting the issue of municipal elections.
- 2) Al Multaqa’s documentation of relevant information forming a basis for analysis and evaluation.
- 3) Neglecting education, health and dropout from schools, which are issues of daily concern to the public in both the social and economic dimensions.
- 4) Lack of elaboration into issues of democratic life within NGOs as if things are moving properly.
- 5) Lack of verification into information with the party in question (Remark by the Attorney General).
- 6) Some inaccurate information concerning the national opposition (check page 78).

In general, there was an appreciation from the public to the effort exerted in preparing the Report, evoking discussion and interaction while contributing to the set objectives.
